**The completed Fill Permit Application must be submitted to the Batavia Town Clerk, 3833 West Main Street Road.**

**Within 5 calendar days after receipt of application, the Town Clerk shall mail a letter to any adjacent property owners advising them of the application and that they have five calendar days to file orally or in writing with the Town Clerk any objection or comments regarding the application.**

**The only type of fill that will be allowed is brick, stone concrete, asphalt and clean soil.**

**All permits are good for only one (1) year from date of issuance and can be renewed up to two additional one-year periods.**
