

APPLICATION FOR FIREWORKS PERMIT

Town of Batavia. Genesee County. New York State

The _____ herein applies to the Town Board of the Town of Batavia for a permit pursuant to Section 405.00 of the Penal Law of the State of New York for the public display of fireworks.

1. Name and address of the body sponsoring the display.

2. Names of the persons actually to be in charge of firin^g the display.

3. Day and hour which the display is to be held.

4. The exact location planned for the display.

5. Age, experience and physical characteristics of the persons who are to do the actual discharging of the fireworks.

6. Number and kind of fireworks to be discharged.

7. Manner and place of storage of such fireworks prior to such displaying.

8. Set forth below a diagram of the grounds on which the display is to be held. showing the point at which the fireworks are to be discharged, the location of all buildings, highways, and other lines of communications, the lines behind which the audience will be restrained and the location of all nearby trees, telephone or telegraph lines or other overhead obstructions.

9. The permit applicant or the person to whom the permit for the public display of fireworks is to be awarded shall post with the Town a surety bond or an indemnity insurance policy with liability coverage and indemnity protection conditioned for the payment of all damages which may be caused to a person or persons or to property by reason of the display so permitted and arising from any acts of the permittee, his agents, employees, contractors or subcontractors. Said bond or insurance policy shall run to the Town of Batavia and state that it shall be for the use and benefit of any person or persons or any owner or owners of property so injured or damaged, and that such a person or persons or such owner or owners, his and their heirs, executors, administrators, successors or assigns are authorized to maintain an action thereon.

All bonds or insurance policy shall be issued by insurance companies licensed or authorized to do business within the State of New York and, unless waived by the Town Board, shall have a Bests rating of "A" or better. In addition, all insurance policies issued shall name the Town of Batavia as an additional insured. Minimum coverage limits shall be as follows: for a surety bond - three million (\$3,000,000.00) dollars; for an insurance policy - one million (\$1,000,000.00) dollars per occurrence, three million (\$3,000,000.00) dollars aggregate.

A surety bond or certificate of insurance in compliance with these requirements shall be provided to the Town prior to the issuance of the permit for public display of fireworks.
