RESOLUTION NO. 170:

Deputy Supervisor Underhill offered the following:

ADOPTION OF 2008 TOWN ANNUAL BUDGET

WHEREAS, the Town of Batavia Chief Fiscal Officer prepared a Tentative Budget for review by the Batavia Town Board, and

WHEREAS, the Town Board met in Budget sessions among themselves and with Town Employees in the formulation of the Preliminary Budget, after which a Public Hearing was held on November 7, 2007 for all interested parties to be heard.

RESOLVED, the Batavia Town Board hereby adopts the Preliminary Town Budget as the 2008 Annual Budget of the Town of Batavia.

Second by: Councilwoman Michalak APPROVED by unanimous vote (4-0)

RESOLUTION NO. 171:

Supervisor Post offered the following:

TOWN OF BATAVIA SEWER RENTS – 2008

WHEREAS, pursuant to General Municipal Law Section 452 as amended, impositions of sewer rents in Sewer Districts No. 1 and No. 2 in the Town of Batavia are subject to approval by the Batavia Town Board; and

WHEREAS, these sewer rents are imposed to pay for the cost of wastewater treatment and operation and maintenance of the sewer lines; and

WHEREAS, in Sewer District No. 1 the sewer rents for 2008 has been set at five dollars and three cents (\$5.03) per 1000 gallons; and

WHEREAS, in Sewer District No. 2 the sewer rents for 2008 has been set at five dollars and three cents (\$5.03) per 1000 gallons; and

WHEREAS, as required by law and in conjunction with the public hearing held November 7, 2007 for the 2008 Town Budget, these rates were entered in and made a part of the record.

RESOLVED, the Batavia Town Board hereby authorizes the imposition of the aforementioned sewer rents in Sewer Districts No. 1 and No. 2 for one (1) year beginning January 1, 2008.

RESOLVED, the sewer rents are to be paid quarterly in the months of May, August and November, 2008 and February, 2009.

Discussion: The Supervisor questioned whether Saile Drive Sewer would be impacted by this resolution or is it going to be a separate district. The Town Engineer explained that the Saile Drive Sewers are benefit improvement areas. There is a ways to go to get a map consolidating the improvement areas to a district.

The Supervisor stated that once the Saile Drive Sewer is up and running a separate resolution will be drafted. The Engineer said it will be similar to Gateway 1.

RESOLUTION NO. 172:

Councilwoman Michalak offered the following:

SEOR DETERMINATION OF NON-SIGNIFICANCE

WHEREAS, in accordance with the State Environmental Quality Review Act (SEQRA) Establishment of a Water District is an Unlisted action;

WHEREAS, the Batavia Town Board acting as Lead Agency has reviewed the Short Environmental Assessment Form addressing the Establishment of Extension No. 1 to the Putnam and Shepard Roads Water District (attached) and;

WHEREAS, it has been determined that the Establishment of the Water District Extension will not have an adverse impact on the environment;

NOW, THEREFORE, BE IT

RESOLVED, The Town Board declares that, based on the Environmental Record, which has been prepared, the project will result in no major impacts and, therefore, will not cause significant damage to the environment. A Negative Declaration under SEQR is therefore issued for this project.

RESOLUTION NO. 173:

Councilman Gerace offered the following:

RESOLUTION AND ORDER FOR ESTABLISHMENT OF EXTENSION NO. 1 TO THE PUTNAM AND SHEPARD ROADS WATER DISTRICT FOR A PORTION OF THE TOWN OF BATAVIA

WHEREAS, the Town Board of the Town of Batavia, duly adopted a Resolution directing Gregory H. Post, the Town Supervisor of the Town of Batavia to file a map, plan and report as prepared by the Town's engineer for providing the facilities, improvements or services in a portion of the Town of Batavia, wherein a water district was proposed to be established, as hereinafter described, and

WHEREAS, after the said Town Supervisor duly filed said map, plan and report in the office of the Town Clerk of the Town of Batavia on October 11, 2007, and the said Town Board, did on October 17, 2007, duly adopt an Order reciting a description of the boundaries of the proposed district, the maximum amount proposed to be expended for the improvement, the proposed method of financing to be employed, the fact that a plan, map and report describing the same are on file in the Town Clerk's Office for public inspection and specifying that said Town Board shall meet at the Town Hall on the 7th day of November, 2007, for the purpose of conducting a public hearing on such proposal to establish the water district with the specified improvements and to hear all persons interested in the subject thereof concerning the same, and

WHEREAS, a "Petition to Request Water District" was filed in the Batavia Town Clerk's Office on October 16, 2007, which was signed by a number of owners within said district, which was greater than the percentage required by law, and

WHEREAS, the improvements proposed are as follows: a project to provide a safe and reliable potable water supply and fire protection to certain residences located within the proposed Water District. The overall project will consist of the construction and installation of eight inch water main along a portion of the Batavia-Bethany Townline Road running from Francis Road to Shepard Road; together with all related right-of-way costs, site work and other ancillary work, including hydrants, valves, apparatus, and other improvements and costs incidental thereto (referred to herein as "water improvement"), and

WHEREAS, copies of the aforesaid said Order for a Public Hearing were duly published and posted according to law, and said Town Board did, at the time and place specified in said Order, duly meet and consider such proposal and heard all persons interested in the subject thereof, who appeared at such time and place, concerning the same, and

WHEREAS, the evidence offered at such hearing requires that the Town Board make the determinations hereinafter made;

NOW, THEREFORE, BE IT RESOLVED, by the Town Board of the Town of Batavia, in the County of Genesee, that it be and hereby is determined as follows:

- (1) The aforesaid "Petition to Request Water District" was signed, and acknowledged or proved or authenticated, as required by law and is otherwise sufficient.
- (2) The Notice of Hearing was published and posted as required by law and is otherwise sufficient.
- (3) That all the property and property owners, within the proposed water district are benefited thereby.
- (4) That all of the property and property owners benefited are included within the proposed water district.
- (5) It is in the public interest to establish the proposed water district as hereinafter described; and be it

FURTHER RESOLVED, that the Town Board does hereby approve the establishment of a Water District as hereinafter described to be known as Extension No. 1 to the Putnam and Shepard Roads Water District. Said Water District being described on **EXHIBIT A**, attached hereto and made a part hereof; and be it

FURTHER RESOLVED, that since the water improvements within the proposed Water District have already been approved as part of the Putnam and Shepard Roads Water District, there will be no additional financing or debt service necessary, and be it

FURTHER RESOLVED that the property owners within the proposed Water District will be required to pay the proportionate share of the debt service previously established in the Putnam and Shepard Roads Water District, along with the existing owners in the Putnam and Shepard Roads Water District, as well as property owners located within a District to be formed in the Town of Bethany along the same section of the Batavia-Bethany Townline Road, and be it

FURTHER RESOLVED that the debt for the Putnam and Shepard Roads Water District is \$373,000.00 to be paid over a 38 year term at 4.25% interest, thereby creating an annual debt service of \$19,950.00, and assuming this annual debt is shared by 59 units in the three Water Districts, the annual cost of debt service will be \$343.00 per typical property user in the proposed district, which is a single family home, and be it

FURTHER RESOLVED that a typical household uses 63,000 gallons of water per year and the estimated cost of the water to be purchased by the water district's users is a total of \$4.11 per 1,000 gallons used, thereby the average household can expect to additionally pay approximately \$259.00 per year for water purchase above and beyond the debt service, and be it

FURTHER RESOLVED that based upon the foregoing estimates, the total annual cost of the typical property in the proposed district will be \$602.00 per year, and be it

FURTHER RESOLVED that payment of the debt service will be made by levy and collection of special assessments from the several lots and parcels of lands within the water district, which the Town Board shall determine and specify to be specially benefited thereby, so much upon and from each as shall be in just proportion of the amount of benefit conferred upon the same, to pay the principal of and interest on said bonds, as the same shall become due and payable, and be it

FURTHER RESOLVED that each property will also have to pay for service from their home to the road right-of-way, incurring an estimated one time cost of approximately \$125.00 for a meter, plus approximately \$8.00-\$12.00 per linear feet of pipe, plus potential well abandonment or separation charges, as well as any internal plumbing charges, and be it

FURTHER RESOLVED that this Resolution and Order is not subject to a permissive referendum; and be it

FURTHER RESOLVED that within ten (10) days after the adoption hereof, the Town Clerk shall post and publish as provided by law a Notice setting forth the date of the adoption of this Resolution and Order and containing an abstract of this Resolution and Order concisely stating the purpose and effect hereof; and be it

FURTHER RESOLVED, that this Resolution and Order is not subject to the approval of the Office of the State Comptroller, Department of Audit and Control, and be it

FURTHER RESOLVED, that the Town Clerk be and she hereby is authorized and directed to record a certified copy of this Resolution and Order in the Office of the Genesee County Clerk, and to file a certified copy of this Resolution and Order in the Office of the State Department of Audit and Control within ten (10) days hereof.

Second by: Councilwoman Michalak APPROVED by unanimous vote (4-0)

Discussion- The Town Board discussed the meter fee and price per linear foot of piping. The meter fee for future districts will increase.
