RESOLUTION NO. 54:

Councilman Lang offered the following:

RESOLUTION TO CONTRIBUTE TO THE LOCAL SHARE FOR THE LGE GRANT PROGRAM AND TO ADOPT AN INTERMUNICIPAL AGREEMENT WITH THE CITY OF BATAVIA

WHEREAS, the Town of Batavia (hereinafter "Town") and the City of Batavia (hereinafter "City") intend to enter into an Intermunicipal Agreement to appoint a Task Force to draft a Consolidation Charter for the merger of the City and Town into a consolidated City of Batavia pursuant to this Consolidation Charter, and

WHEREAS, the City and Town desire to contribute equally to the local share needed to obtain a Local Government Efficiency (LGE) grant for the 2009-2010 year.

NOW, THEREFORE, BE IT RESOLVED by the Town Board of the Town of Batavia, New York that it hereby expresses intent to work cooperatively with the City to appoint a Consolidated Charter Task Force and to adopt a Consolidated Charter that would merge the City and Town into one governmental unit subject to referendum, and be it further

RESOLVED that the Town Board acknowledges that the City plans to submit an application requesting funding from the State of New York under the Local Government Efficiency (LGE) Grant Program, and that these grant funds are to be used to retain consultants to facilitate the process of preparing a Consolidated Charter that would provide the basis for a proposed merger, and be it further

RESOLVED that the Town Supervisor is hereby authorized and directed to execute all necessary financial and administrative documents and instruments relating to the Grant Program on behalf of the Town, and be it further

RESOLVED that the estimated cost for consulting services is \$55,000.00, and the City will apply for a maximum LGE grant of \$49,500.00, and thereby, the local share of the grant project will be \$5,500.00, and be it further

RESOLVED that the Town does hereby approve the expenditure of \$2,750.00 from the appropriate budget line item to provide one-half of the local share, and be it further

RESOLVED that a proposed "Intermunicipal Agreement by and between the City of Batavia, New York and the Town of Batavia, New York to appoint a Consolidated Charter Task Force", a copy of which is attached and made a part of the Town Board Minutes, is hereby approved and adopted, and the Town Supervisor is authorized and directed to execute this Intermunicipal Agreement on behalf of the Town.

INTERMUNICIPAL AGREEMENT BY AND BETWEEN THE CITY OF BATAVIA, NEW YORK AND THE TOWN OF BATAVIA, NEW YORK TO APPOINT A CONSOLIDATED CHARTER TASK FORCE

THIS AGREEMENT, made the _____ day of ______, 2010, by and between the CITY OF BATAVIA, NEW YORK, a Municipal Corporation of the State of New York, with offices located at City Hall, 1 Batavia City Centre, Batavia, New York 14020, (hereinafter referred to as the "City"), and the TOWN OF BATAVIA, NEW YORK, a Municipal Corporation of the State of New York, with offices located at 3833 West Main Street Road, Batavia, New York 14020, (hereinafter referred to as the "Town").

WITNESSETH:

WHEREAS, the City and Town have jointly committed to study potential cost savings for its respective residents, including shared services and the possible consolidation of the two municipalities into a single entity, and

WHEREAS, the Town and City jointly created a Consolidation Study Committee whose work was funded from a grant obtained by a joint application to New York State for a Shared Municipal Services Incentive Grant, and

WHEREAS, on July 29, 2009, the Consolidation Study Committee issued to the City Council and

the Town Board a final report entitled "Plan for Consolidating the City & Town of Batavia in One Government", and

WHEREAS, this final report recommended a model for the merger of the City and Town into a consolidated City of Batavia with a Consolidated Charter, and

WHEREAS, the final report recommended that the Town and City create an entity to draft a proposed Consolidated Charter, and

WHEREAS, pursuant to Article 5(G) of the General Municipal Law, the Town and City are entitled to enter into the current Intermunicipal Agreement to undertake together the process set forth hereinafter to continue to study and move forward with the creation of a Charter mechanism to be submitted to the respective voters of the City and the Town for their consideration.

NOW, THEREFORE, in consideration of the mutual covenants and agreements contained herein, it is agreed as follows:

- 1. Within thirty (30) days of confirmation of the receipt of appropriate funding, the City Council and the Town Board shall appoint an Interview Committee to select a Consolidated Charter Task Force to consist of four (4) City residents and four (4) Town residents. All members of the Task Force must be at least eighteen (18) years old; however, individuals in the following categories shall not be considered for inclusion upon the Task Force:
 - A. All members of the City Council and the Town Board.
 - B. All members of the Planning Boards and the Zoning Boards of Appeals for both the City and the Town.
 - C. All employees of the City and of the Town.
 - D. All spouses of any individuals in the above three categories.
- 2. The Interview Committee shall consist of the City Council President and two (2) City Council Members and the Town Supervisor and two (2) Town Board Members.
- 3. The Interview Committee shall be authorized and directed to advertise for at least thirty (30) days in the official newspaper of the Town and City, and any other desired local media outlet, to solicit applications for the Task Force. Thereafter, the Interview Committee shall conduct interviews as they deem necessary to select the recommended eight (8) members to be submitted to the City Council and Town Board. Each individual recommendation must be approved by a unanimous vote of the Interview Committee.
- 4. Within thirty (30) days of receipt of the recommendations of the Interview Committee, the City Council and the Town Board shall each appoint and approve by Resolution all eight (8) of the proposed Consolidated Charter Task Force Members; with the provision that each proposed member shall be deemed approved unless <u>rejected</u> by at least four (4) votes from the Town Board and at least six (6) votes from the City Council.
- 5. The mission of the Consolidated Charter Task Force is to develop a new Charter for the consolidated City of Batavia that reflects the efforts and recommendations set forth in the "Plan for Consolidating the City & Town of Batavia in One Government", issued in the Final Report of the

Consolidation Study Committee on July 29, 2009. However, the Task Force is not bound by the recommendations set forth in this Final Report, and it is free to accept or reject those recommendations or concepts as it deems appropriate. The Charter will serve as a framework for the new form of government. At all times, the Consolidated Task Force shall attempt to promote recommendations that will provide the most efficient and cost effective local government to the residents of the City of Batavia and Town of Batavia while maintaining the highest quality of services available.

- 6. The duties of the Consolidated Charter Task Force shall be as follows:
- A. To expend funds as necessary to carry out its functions as hereinafter stated within the budget guidelines and categories of the grant funding obtained by the City and Town.
- B. No expenditure shall be made above and beyond the grant funding guidelines and categories, without the express prior approval of both the City Council and the Town Board.
- C. The City Council and the Town Board shall remain fully, and jointly responsible for the appropriation and expenditures of the grant fundings and reserve the right by respective resolutions to direct or limit any specific expenditure by the Task Force.
- D. Provide itemized monthly financial reports listing all expenditures for each month and to date.
- E. Meet as often as it deems necessary and provide status reports to a joint meeting of the City Council and the Town Board every three (3) months.
- F. Obtain information and documentation from all available sources necessary, including to obtain opinions and guidance from consultants and legal counsel; as well as from the public at large.
- G. Provide a draft Charter document to both the City Council and the Town Board no later than July 30, 2011.
- H. At all stages of this process, with a greater emphasis after the draft Charter has been submitted, hold numerous community meetings and public hearings to solicit as much public input as is possible, and to disseminate information to as many of the City and Town residents as is possible.
- I. To release information regarding the progress of the Task Force through local news media sources, advertising, printings or mailings, with a greater emphasis after the draft Charter has been submitted.
- J. Submit a final proposed Consolidated Charter to both the City Council and the Town Board no later than December 31, 2011.
- 7. Upon receipt of the final proposed City of Batavia Charter for the proposed consolidated City and Town of Batavia, the City Council and the Town Board shall consider adopting resolutions or local laws as needed to request authority from the New York State Legislature, or otherwise, to permit the City of Batavia and the Town of Batavia to hold a referendum in each municipality to determine whether or not the City and the Town should merge to expand the boundaries of the City to encompass the Town, pursuant to the terms and conditions of the proposed Charter.
- 8. Upon receipt of the necessary authorizations, both the City and the Town shall conduct a referendum, either pursuant to the terms and conditions of the authorizing legislation, if so required, or otherwise pursuant to existing procedures for permissive referendums that are held within the City of Batavia and within the Town of Batavia.
- 9. There shall be no consolidation or implementation of a proposed Charter until these proposals are accepted by a majority of the qualified and authorized voters in both the City of Batavia and the Town of Batavia.

RESOLUTION URGING THE NEW YORK STATE LEGISLATURE TO SUPPORT THE STATE'S FARMLAND PROTECTION PROGRAM AND ENVIRONMENTAL PROTECTION FUND

WHEREAS, agriculture is a significant contributor to New York's economy; and

- **WHEREAS**, farms provide jobs, support local businesses and are part of industry sectors that have a \$23 billion economic impact annually in New York; and
- **WHEREAS,** farms comprise 7 million acres of land in New York, roughly 25% of the state's land base; and
- **WHEREAS,** farmers have a strong track record of pro-active environmental stewardship in New York; and
- **WHEREAS,** rapidly changing economic conditions threaten the future viability of New York's agricultural industry; and
 - WHEREAS, 26,000 acres of farmland are developed each year in new York; and
- WHEREAS, the State of new York established a Farmland Protection Program in 1992 to assist towns and counties in developing and implementing local agricultural and farmland protection plans; and
- **WHEREAS**, over \$3 million has been awarded by the Farmland Protection Program to 50 counties and 52 towns to assist in the development of local agricultural and farmland protection plans; and
- **WHEREAS**, the Farmland Protection Program has awarded more than \$173 million to help farmers, local governments and land trusts permanently protect 74,000 acres on 303 farms; and
- **WHEREAS**, demand for Farmland Protection Program funding has been strong due to the program's popularity, with a record 181 farms seeking \$156 million in state funding to protect 49,500 acres in 2008; and
- **WHEREAS,** funding for the Farmland Protection Program is allocated from the state's Environmental Protection Fund (EPF), a dedicated fund whose principle funding source is a state Real Estate Transfer Tax (RETT); and
- **WHEREAS**, the Governor and State Legislature must take steps this year to protect New York's valuable farmland and strengthen the future for farms across New York.

NOW, THEREFORE, BE IT

- **RESOLVED,** that the Town of Batavia does hereby urge state lawmakers to support New York's farmers, the state's agricultural economy and protection of valuable farmland by supporting funding for the Farmland Protection Program and Environmental Protection Fund; and be it further
- **RESOLVED,** that the Town of Batavia does hereby oppose to drastic cuts to the Farmland Protection Program and Environmental Protection Fund, as outlined in the Governor's FY 2010 Budget Proposal; and be it further
 - **RESOLVED**, that the clerk of the Town of Batavia is hereby directed to forward copies of this

resolution, along with the attached letter of support to Governor David Paterson, Senate Republican Leader Dean Skelos, Senate President Pro-Temp Malcolm Smith, Senate Democratic Conference Leader John Sampson, Assembly Speaker Sheldon Silver, Assemblyman Steven Hawley, Senator Michael Ranzenhofer, and the American Farmland Trust.

I am writing to ask for your support for funding for New York's Farmland Protection Program (FPP). This program strengthens farms and related businesses as farmers are paid to protect their land and frequently reinvest the proceeds in buying new tractors and equipment, constructing new buildings, reducing business debt and spurring rural economies. At the same time, irreplaceable farmland is being permanently protected for future generations.

Agriculture is the top employer in Genesee County. Each dollar earned or job created by dairy or crop farming generates an additional two jobs or dollars in other sectors of the economy. Farming has among the highest employment and "value added multipliers" of any industry.

The need for funding from Environmental Protection Fund (EPF) programs like FPP has never been higher. In 2008, there were \$156.5 million in FFP projects pending across New York to protect 181 farms on 49,500 acres. The represents 7 times more demand for funding than the \$22 million in funding available in the 2009-10 State Budget.

It is vital to continue the Farmland Protection Program in our community for the additional funds to create

better "Plans" and the ongoing effort to monitor the implementation of the Agricultural and Farmland Protection Plans. To stop the process by denying access to the money that we paid in taxes for this program is unacceptable, and we hope you will assist us in our efforts to strengthen this program.

It is widely recognized that difficult budget decisions will need to be made by state leaders in the coming weeks and months. However, Governor Patterson's FY 2010-11 State Budget proposal would disproportionately cut EPF funding by 35%, including a 55% reduction in FFP funding. I am asking for your leadership in strengthening New York's commitment to our farms, local food security, rural economy and environment. I hope you will actively support:

- Appropriating \$222 Million for the EPF including \$23 million for EPP:
- Opposing "offloads" of program costs to the EPF that have traditionally been paid from other areas of the budget and diminish funding for core environmental programs like FPP;
- Developing a Multi-Year EPF Repayment Plan to make up for the roughly \$500 million borrowed from the EPF for non-environmental funding that has left the state unable to fulfill its EPF funding commitments.

Thank you for your commitment to programs like the state's Farmland Protection Program that are spurring New York's economy while protecting our environment and strengthening our communities.
