AUTHORIZATION TO SUBMIT A GRANT
APPLICATION TO THE GOVERNOR'S OFFICE FOR SMALL CITIES

WHEREAS, Certified Graphics & Communications, LLC plans to purchase and renovate an existing 24,000 square foot facility at 4300 Commerce Drive within the Batavia Gateway Corporate Park in the Town of Batavia, and

WHEREAS, Certified Graphics & Communications, LLC plans to create 28 new jobs for Genesee County and New York State at the site, and

WHEREAS Certified Graphics & Communications, LLC requires financial support from the Governor's Office for Small Cities to finance part of the project. Now, therefore, be it

RESOLVED, That the Batavia Town Council hereby authorizes the Supervisor to submit a grant application in the amount of \$416,000 to the Governor's Office for Small Cities, based on the estimated job creation, and Be it further

RESOLVED, That the Batavia Town Council authorizes the Supervisor to execute all other necessary documents associated with the Governor's Office for Small Cities grant approval, subject to review by counsel, and Be it further

RESOLVED, That the Batavia Town Council authorizes the Supervisor to serve as "Certifying Officer" for the purposes of assuring compliance with all federal environmental regulations and representing the Town of Batavia in any challenge to such compliance of the Small Cities grant.
